<sup>1</sup> **The burden of proving a permanent source of income rests with the student.** The student may document it by presenting e.g. a certificate of employment from the workplace, civil-law contracts (contract of mandate, specific task contract), decisions of a competent body on granting a pension, court judgment awarding maintenance, etc.

### Information Clause for a student applying for a scholarship benefit
